



CONDITIONS OF REGISTRATION

This registration is granted subject to the following conditions, namely: —

- (i) The promoter shall submit approved service estimates and plans, Environment Clearance, Fire Scheme NOC and Electric Load availability within a period of 3 months from issuance of this certificate.
- (ii) The promoter shall follow the respective payment plan for AHP and PMAY (U) as per respective policies of Town and Country Planning department, Haryana as amended from time to time.
- (iii) The promoter shall enter into an agreement for sale with the allottees as prescribed by the Government.
- (iv) The promoter shall offer to execute a registered conveyance deed of the apartment, plot or building, as the case may be, in favour of the allottee along with the undivided proportionate title in the common areas to the association of allottees or competent authority, as the case may be, as provided under section 17 of the Act.
